THE PROVISIONS FOR ADMITTANCE OF INTERNATIONAL STUDENTS

Application Requirements

(The provisions for admittance of international students of Turkish Higher Education Institution)

Eligible applicants

- a) Eligible applicants a)** On condition of being a final year/senior high school student or being a high school graduate;
- 1) Foreign nationals,
 - 2) Turkish citizens by birth but who ceased to be a citizen of Turkey with the permission of the Ministry of Internal Affairs; and the under aged children of such people who are registered in their parent's document of alienage and can certify that they have the "Certificate Regarding the Exercise of Rights Given by Law" which is obtained in accordance with the Turkish Nationality Law (According to Article 7 of the 5901 Turkish Citizenship Law, (1) "Children born to married Turkish parents, in Turkey or abroad, are considered as Turkish Citizens." Applicants who apply from abroad should refer to the Turkish Citizenship Law),
 - 3) Former foreign nationals who acquired Turkish citizenship afterwards; and dual citizens who comply with this criterion,
 - 4) (a) Turkish nationals who have been continuing their secondary education in a foreign country before 01.02.2013 and have completed the last three years of their secondary education (high school) in a foreign country other than the Turkish Republic of Northern Cyprus (TRNC) (including the ones who have completed their secondary education [high school] in Turkish schools opened by the permission of the Ministry of National Education which are located in foreign countries other than TRNC),
 - b) Turkish nationals who have started their secondary education in a foreign country after 01.02.2013 and have completed their entire secondary education (high school) in a foreign country other than the Turkish Republic of Northern Cyprus (TRNC), (including the ones who have completed their secondary education [high school] in Turkish schools opened by the permission of Ministry of National Education which are located in foreign countries other than TRNC),
 - 5) TRNC nationals who reside in TRNC and have completed their secondary education in TRNC and hold GCE AL exam scores; and those who are TRNC nationals registered in and received education at colleges and high schools in other countries between 2005 - 2010 and who hold or will hold GCE AL exam scores.

Ineligible Applicants

- 1) Turkish Citizens who have completed their entire secondary education in Turkey or the TRNC (Turkish Republic of Northern Cyprus),
- 2) TRNC Citizens (except for those who have completed their entire secondary education in the TRNC high schools and hold GCE AL test scores and those who have registered in and received education at a college or high school in other countries between 2005 - 2010 these schools and hold or will hold the GCE AL test scores),
- 3) Dual citizens with the first nationality being Turkish by birth as defined in the Clause 2 of Article a (excluding those who satisfy conditions in Clause 4 of Article a),
- 4) Dual citizens with either of their citizenship being that of TRNC (except for those who have completed their entire secondary education in TRNC high schools and hold the GCE AL test scores and those who have registered in and received education at a college or high school in other countries between 2005 – 2010 these schools and have or will hold GCE AL test scores),
- 5) Turkish citizens or dual citizens with the first nationality being Turkish by birth as defined in the Clause 2 of Article a and who have studied in schools within the body of embassies in Turkey or international high schools located in Turkey.

***Note: Candidates will take the exam based on the stated information. University Administrative Committee decisions will be taken as a basis on student placements.**

Procedure for Online Application

- Applications for the 2018-2019 Training Year will be proceeded according to the scores in Table 1 between the dates 20th,June-23rd, July 2018
- The candidates will have to complete the requested documents (photo, examination score paper) and load them into the system
- Application in person and via e-mail will not definitely be accepted
- The documents, the declaration, the score have to be definite and true during the application process
- The original copies of the documents have to be handed over to the officials
- In case of any missing documents, the application of any candidate will be canceled
- The loaded documents have to be clear and the same as in the application form
- E-mail address has to be definite and true
- There is no any fee for the application
- Each applicant can proceed only one application and prefer maximum 5 programmes
- In the case of identifying more than one application for one applicant, the whole application is to be canceled
- The applications are to be evaluated according to the instruction of International Students Acceptance to graduates and undergraduate programmes of Ordu University

The Requirements and Instructions of Higher Education Institutions

See 15. One year English Language preparatory program is compulsory. The duration of the preparatory program is not included in the total number of years of study required for graduation shown in the columns for education period. The students who are successful in English Language Exemption Test can directly begin the first year of their program. Students are subject to the provisions of ‘‘Regulations on Foreign Language Teaching in Higher Education Institutions and the Principles that will be followed in Foreign Language Teaching’’.

See 46. A one-year English Language Preparatory Program is offered for the students wishing to attend English Language Course within the available quota. The duration of the preparatory program is not included in the total number of years of study required for graduation shown in the columns for education period.

See 86. At least 30% of the instruction of the program is given in English.

REGISTRATION

- The list of admitted candidates will be announced on <http://www.odu.edu.tr/> . The applicants will not be informed in other means
- The documents for exact registration are obligatory to complete the exact registration process
- The admitted students will have to hand over the registration documents to the International Students Office of the Department of Students Affairs during the specified time. Registrations will be conducted by the Department of Students Affairs
- The candidates who are not able to complete the registration process and provide the required documents within the specified time will lose their registration access and they are supposed to give up the study access
- Registration is not possible on internet or by mail
- In case of missing quato, a placement procedure will be proceeded again and the admitted candidates will be announced and registered
- For the admitted students for exact registration (who are not having Turkish Proficiency Certificate), Turkish Proficiency and Exemption Test will be delivered by Turkish Teaching and Application and Research Center
- In case of identifying a candidate's false documents, his/her registration will be ended and his/her all study rights will be canceled
- According to the law "6486", the foreign students who don't hold social security assurance and demand "General Health Insurance" in 3 months' time they have to apply to social security institution or else they will not have the service during their study period
- The students to study at Ordu University will have to hold student's visa If they don't have "Residence Permit". The students on defined circumstance will have to apply to the nearest Turkish Consulate nearby Ordu province with the acceptance letter provided by Ordu University

THE DOCUMENTS FOR EXACT REGISTRATION

- 1.** The original exam score report or a copy confirmed by the authorized institution and document code on it.
- 2.** The original copy of high school diplom with Turkish translation confirmed by Turkish external representatives.
- 3.** The original copy of transcript or Turkish translation of transcript confirmed by notary or Turkish external representatives.
- 4.** The equivalency certificate of the diplom taken from (the Department of National Education in local area or Turkish external representatives).
- 5.** The passport with education visa or a Turkish copy of passport confirmed by notary or Turkish external representatives.
- 6.** Residence paper and a foreign –nationalized ID number (it must be delivered to the student’s Office in a month). Those who have got ‘‘Residence Permit’’ in Turkey will deliver ‘‘Residence Document’’.
- 7.** Those with Turkish nation ID , keep ID card copy with you. Those holding ‘‘blue card’’, keep the original copy with you.
- 8.** Those who registered as foreigner at birth but later accessed to Turkish citizenship have to hand over their identity register copy.
- 9.** The declaration of military service for those with Turkish nation identity.
- 10.** A commitment letter displaying that the person has specified his/her financial assurance amount.
- 11.** The receipt of the study fee from bank.
- 12.** Photos (6)
- 13.** If available, foreign language or Turkish language certificate

TURKISH LANGUAGE PROFICIENCY LEVELS

(1) Turkish Language Proficiency Levels

- C1 : proficient-having Access to study at Ordu University
 - B2 : having a Turkish level to improve in a short time. The student can start studying at Ordu University. However, he/she has to reach C1 level until graduation. On condition that he/she has to take Turkish course held by TÖMER (Turkish Teaching Center or ODU (Turkish Teaching Center). The students who are at the graduation period can not be graduated till they reach C1 level.
 - B1-A2-A1 : incompetent – the candidates having these levels are supposed to leave the study for 1+1 year. Those who can not reach the proficient level are free of study for one more year.
 - At the end of the periods, the study of those who can not prove the proficiency level in Turkish language is ended with Ordu University.
- (2) The candidates for application have to prove Turkish language Level Score (The certificate/ document taken from Yunus Emre Institution and TÖMER (Turkish Teaching Centers)**
- (3) Those who can not prove the Turkish Language Level Score have to take Turkish Language Proficiency Exam held by TUYAM at Ordu University.**

THE LIABILITIES OF INTERNATIONAL STUDENTS

The admitted students or the applicants to Ordu University ;

- a) have to hand the requested documents in the related office
- b) have to apply for the ‘ Residence Paper’ to migrant office in Ordu Province (in one month’s time after entrance to Turkey)
- c) have to complete all the procedures specified in Turkish Republic Laws and report all his/her personal information in detailed in 15 days’ time
- d) in case of losing the passport or residence paper , have to apply to the related office and get a new one in 15 days’ time
- e) in case of changing of residence address, have to inform the changes to the migrant office in 48 hours’ time
